### Master of Fine Arts

The MFA is a graduate level, terminal degree in studio art. Each graduate candidate is entitled to a private work studio, along with 24-hour access to all studio facilities. Teaching assistantships that include stipend and full tuition are available for qualifying students based on portfolio review and financial need. A minimum of two years of study, or 60 credits in studio, theory, and art history classes fulfill the program requirements.
