- 101.01 These SGC-BBC Statutes can be amended by no less than ²/₃ vote of the entire Senate.
- **101.02** Senate bills to amend Statutes shall require two (2) readings if it involves changing only one article or chapter. Bills that amend more than two articles or chapters will require three (3) readings from the Senate.
