Section 1: The definition of “emoluments” and the change of Executive Committee to Executive Board were added.

Section 2: **Chapter 103 Definitions of Terms**

(ix) Emoluments: A document which contains the stipends for all positions during an academic year.

(xi) Executive Committee Board: Board comprised of the Student Body President, Student Body Vice-President, Speaker of the Senate, Speaker Pro-Tempore, Chief Justice of the Supreme Court, and Comptroller. The advisor shall serve as an ex-officio member.

Section 3: This proposed bill shall be implemented immediately during the Spring Semester of 2013 as soon as a super majority vote of the Senate passes it.
