Section 1: This proposed action defines when and how often the University-Wide Council is required to meet.

Section 2 Composition


The UWC shall be composed of voting members and non-voting members. The President, Vice President, Speaker of the Senate, and Speaker Pro-Tempore from both SGC-MMC and SGC-BBC shall serve as voting members. The Comptroller and Chief Justice from both SGC-MMC and SGC-BBC shall serve as non-voting members.

A. ~~The UWC shall meet at least once a month, during the last academic week of every month, alternating between MMC and BBC campuses. The first meeting shall be at the SGA Retreat.~~ **The UWC shall meet at least twice a semester, Fall, Spring, and Summer (A, B, and, C), alternating the location of each meeting between MMC and BBC campuses.**

1. **The UWC during the summer meeting will review the constitution and make any required revisions.**

Section 3:

This proposed action shall be implemented in the Spring semester of 2017; contingent on a three fifth (3/5) majority of those voting in the special election of November 29th, 2016.
