To amend Section 404.11 Director of Lectures in Article IV of SGC-BBC Statutes

Section 1:

Article IV, section 404.11 of the SGC-BBC Statutes will be amended to remove subsections 2, 3, 5, 7, and 8 in their entirety. The duty to oversee a Lectures Committee will be outlined as subsection 2. Subsection 3 will give the Director of Lectures the power to establish meeting times for the Lectures Committee. Two subsections will be written to give the Director of Lectures some oversight into events programmed by the Lectures Committee. The numbering of subsections in Section 404.11 will be adjusted following the passing of this legislation.

Section 2:

404.11 Director of Lectures shall:

- (i) Maintain a minimum of five (5) office hours per week in office.
- (ii) Recommend an Assistant Director to the SGC-BBC President with notification the Senate. Oversee a Lectures Committee consisting of students that are nonmembers of SGC-BBC.
- (iii) Make recommendations for the creation of additional officers within this office.
- (iv) (iii) Set committee meeting times at a minimum of twice a month. bi-weekly at a time decided on by a majority of the members of the Lectures Committee.
- (v) Report bi weely to the Senate or full Student Government Council on the activities of the office.

- (vi) (iv) Have recorded minutes and agendas to be turned in to the Press Secretary and SGC-BBC Clerk for documentation.
- (vii) Perform other related functions as directed by the SGC-BBC President.
- (viii) Make recommendations to the Student Senate in passing legislation on pertaining issues to the office.
- (v) Act as the student liaison between SGC-BBC and Lectures Committee speakers.
- (vi) Assist SGC-BBC and WUC staff in programming and organizing a Lectures Committee event.
- (ix) (vii) Any other duties assigned by the President, Vice President, and/or Chief of Staff.

**Section 3:** 

This section of the bill shall be implemented immediately during the Summer semester of 2017 contingent upon a Majority vote of the SGC-BBC Senate.
