<u>Old Business</u>: Everyone was reminded that S.G.C. registered voters could take a class to become Registrars in order to register more people to vote for the Ad-Valorem tax initiative. People are going to meet in the Housing community room on Wednesday at 1:00 P.M. to go to the Government Center to take the class to become registrars.

Mimmo Sollazo stated that a letter is needed which states the F.I.U. N. Campus needs the the best speaker can be sent here.

The Budget was then discussed. The main debate was over the purpose of the University Center Programming Committee (UCPC). Guerda also questioned the amount of money allocated to the S.O.C. for travel and also she feels the S.O.C. needs more money to handle the new organizations coming to this campus.

A motion was made by Liz Jacobi and seconded by Cori Basulto to approve the proposed budget as amended.

After the discussion was over, the President called the question. The vote passed with 7 people for the motion, Guerda Jean-Baptiste voted against, and Javier Delgado, Arthur Papillon, Cori Basulto and Richard Williams each abstained. The motion passed 7 to 1 to 4. <u>New Business</u>: It was pointed out that there will be five new majors in the School of Business when the Fall 1994 semester begins. Brian Abramson then asked the Coucil if he could make a statement of the S.G.C.'s opposition to the proposed site of an ampitheatre near the N. Miami campus. A motion was made and seconded to that effect with three abstentions.
