**VICE PRESIDENT'S REPORT**

President Burton did the Vice President's report. Ms. Burton began by welcoming us into the new fiscal year. As of July 1, the two OPS positions on the Council are official. Those positions are Chief of Staff and Executive Assistant to the Vice President. Ms. Burton also welcomed officially to the Council Ms. Liana Perez, candidate for Director of Community Relations. Ms. Perez has shown lots of interest in this position, and she even attended the SGC Retreat. With regard to absenteeism, some members are technically off the Council because they have missed a number of Council and Committee meetings. This issue will be discussed further at our next Council meeting. Ms. Burton informed the Council that there would be a Council meeting next week and not a Committee meeting. Please be advised of this.

- Mr. Richards praised Ms. Mahasin Salahuddin for the hard work that she had put into the Internship Program. Approximately 122 people had signed up for the program so far. He also thanked everyone who attended the Orientation Club Fairs on behalf of SGC. Council members were reminded that they need to punch in and out on the computer in the office. This needs to be done in order for an accurate record can be kept of office hours. Members also need to remember to turn in their weekly reports.
- At this point, Ms. Liana Perez presented her platform for election to the position of Community Relations Chair. Ms. Perez stated that her major goal is to increase FIU's visibility in the community. In order to do this Ms. Perez has several projects in mind. These projects are: the implementation of a certificate program to recognize and honor those students who have participated in community service; a group project with the Volunteer Action Center; starting a WISH program and working closely with Habitat for Humanity. Ms. Perez plans to start networking with clubs that are involved in community service and volunteering and also with the media.

**ADVISOR'S REPORT**

Ms. Plissner reported that orientation had gone really well so far. On July 15 and 16, some students will be staying the night at the residence hall. Ms. Plissner urged SGC to get involved in Welcome Week activities for housing, and also to start putting together plans for North Campus Welcome Week. It would be best for SGC to have its plans in early and get requisitions in early even though no deadline has been set for submissions to the calendar.


