#### **CALL TO ORDER**

Mr. Kunga Kihohia, SGC President, called the meeting to order at 6:11 p.m. He welcomed the Council to another meeting. Ms. Katrina made a motion to accept the minutes as submitted. Mr. Peter Gallego seconded the move. The vote passed unanimously.

#### PRESIDENT'S REPORT

Mr. Kihohia expressed his discontent with the participation of the Council in the Rally for Life event. Rally for Life was an event that raised awareness about cancer. Mr. Kihohia stressed the importance of attending these types of events as they connect Student Government with the community.

#### ROLES AND RESPONSIBILITIES:

The "Roles and Responsibilities" contract needs to signed, dated, and submitted as soon as possible. Also, each member needs to read and understand the rules, regulations, and procedures of the office. Members can pick up a copy of these regulations from Ms. Barbara Levy, Office of Campus Activities Senior Secretary.

Student Government is in the process of receiving a new time clock. Until it arrives, the Council needs to sign in and out with Ms. Levy. Those members who perform their hours after 5 p.m. need to speak with Mr. Omaghomi or Ms. Jones to make arrangements.

#### STUDENT SERVICES

Ms. Jones informed the Council that she expected to meet with each Council member personally. She will be working very closely with each committee chairperson.

#### **NEW BUSINESS**

The Senate was a concept that was developed during the last term. Mr. Kihohia will like this to carry over to this term. The Senate will comprise all of the voting representatives. Whereas, the appointed members will comprise the Executive Board. The Senate will be redeveloped and reshaped in depth by Ms. Avia Rice and Ms. Dannielle Boyer. They will make a presentation at the SGC Retreat.

#### **APPOINTMENTS**

Broward Representative:

Ms. Gayane Stepanian was nominated for this position. She was the only candidate for the seat as the Broward Representative. She was given 5 minutes to present her platform. Ms. Avia Rice made a motion to appoint Mrs. Stepanian to this position. Ms. Katrina Davey seconded the motion. DISCUSSION: There was discussion on Ms. Stepanian's plans towards the issues of the Broward campus and concerns. She responded that the first and major problem with these campuses is its parking. She hopes to make these types of changes if appointed. VOTE: Unanimous.

#### Academic Affairs Chairperson:

Mr. Alioune Pallaye Kane was nominated for the position as Academic Affairs Chairperson. In addition, he was given 5 minutes to present himself to the Council. Mr. Tito Omaghomi made a motion to appoint Mr. Kane as the Academic Affairs Chairperson. Ms. Gloria Bryan seconded the motion. DISCUSSION: Mr. Kane was asked, "How do you plan on

letting students know about the services offered in your committee?" Mr. Kane responded, "..through surveys, and just letting people know." In addition, Mr. Kane plans reinstate the Teacher Evaluation Booklets. He feels as though this is a good way to provide students with good knowledge the will help them make excellent choices in what classes to take. VOTE: 8 in favor, 1 opposed, 0 abstentions.

Director of Student Lobbying/ Community Relations:

Since Ms. Melissa Tapanes has resigned from this position, Mr. Alois Odhiambo was nominated for it. Mr. Odhiambo is a transfer student from Barry University. He feels that there is a lack of communication between SGC and the students. Mr. Odhiambo's goal is to get the students involved. Mr. Tito Omaghomi moved to appoint Mr. Odhiambo as the Director of Student Lobbying/Community Relations. Ms. Dannielle Boyer seconded the move. DISCUSSION: He was asked about his knowledge of FIU's goal in gaining a law school. He responded that he has some knowledge from his research in the past 2 days, has spoken to Ms. Tapanes and has plans on becoming heavily involved in this effort. VOTE: Unanimous.

#### COMMUNITY COMMENTS:

Mr. Zapata announced that all potential activities are due by Tuesday, June 15, 1999. Also, for those Council members who can make it, FIU vs. FAU has a College Bowl Baseball series at 3:30 p.m. at the University of Miami this Friday.

Mr. Zapata announced that there is an intern working with Campus Activities but mostly with Ms. Veneisha Scott. Ms. Davey and Ms. Bryan will be speaking to Orientation students about Student Government but the Council will have many other opportunities to speak. The next Orientation dates are June 16 – 17, 21 – 22, and the 24 –25.

Renovations on the 3<sup>rd</sup> floor of the Wolfe University Center will take place this summer.

Dr. Patricia Telles-Irvin has asked for a "How to Make Goals" session to be added to the SGC Retreat

Mr. Cole added that the Miami Commissioner's meeting was held last week about the penny tax for FIU. Mr. Cole thanked Mr. Kihohia for gathering people for this effort, despite the participation of each campus (UP had a week's notice and NC had a 12 hour notice). In return, Mr. Kihohia thanked the Council for their support. Good news, it was passed.
