

### CALL TO ORDER

Mr. Kunga Kihohia, SGC President, called the meeting to order at 6:08 p.m. He welcomed the Council to another meeting. He asked the Council to review the minutes from the two previous meetings (June 22 and July 6). Ms. Gloria Bryan moved to approve the minutes from the June 22 and July 6 SGA meetings. Mr. Angel Garcia seconded the motion. VOTE: Unanimously.

### PRESIDENT'S REPORT

Mr. Kihohia announced that certain Council members are currently not on the Council. Mr. David Dajani had to go back to his country to take care of his visa. Mr. Alberto Kan will be taking all of classes on the South Campus, therefore, making him ineligible to remain on the Council. Mrs. Gayane Stepanian will be taking maternity leave. The Council is, indeed, currently looking for Hospitality, College of Urban and Public Affairs, Broward, and Nursing Representatives as well as University Relations/Special Events Chairperson.

Ms. Monica LaFrance, Ms. Gloria Bryan, and Ms. Dannielle Boyer are all celebrating birthdays in July. There will be a special celebration for them at the end of the month.



The FIU Law Rally was declined its mission. The Board of Regents turned down FIU's and FAMU's attempts to gain a law school.

Ms. Dannielle Boyer has been hospitalized due to surgery she had recently undergone. Her mother has informed Student Government that she will recuperating very well and should be on her feet very soon.

### VICE-PRESIDENT'S REPORT

Council members were asked to submit their changes as soon as possible.

Mr. Mitch Santilmon has been removed from the Council due to 3 missed meetings. Mr. Omaghomi gave him the floor to explain his absences. Ms. Gloria Bryan moved to re-appoint Mr. Santilmon as the Athletics Coordinator. Ms. Avia Rice seconded the motion. VOTE: 7 in favor, 0 oppositions, 1 abstention.
