SPEAKER OF THE SENATE REPORT

SPEAKER PRO TEMPORE REPORT

- A. Senator Usma found out from the Senate the date and time each Dean is available for the Meet The Dean event. Senator Sanchez then said the Hospitality Dean has been confirmed for attendance.
- B. Senator Usma also tried to find out if the SGC-BBC senate can have their meetings at the Broward Pines Center. He also stressed the importance of showing the presence of SGA at the Broward Pines Center. Since most Senators have class immediately after meetings,

- the entire senate stressed the impossibility of having a meeting at the Broward Pines Center. However, Senator Adekoya, Senator Delly and Senator Yamini said they could make the meetings at the Broward Pines Center on Monday and on Wednesdays.
- C. Senator Usma congratulated the Senate for doing a good job in their weekly reports and also stressed the importance of doing weekly reports for those Senators who don't do weekly reports.

FINANCE CHAIR REPORT

- A. Senator Odimayo stated that in the finance meeting held on September 16th, 2011, the committee approved the finance request of Mr. Xiaoyang Zhang for \$300.
- B. Senator Odimayo also stated that two finance request had been received earlier in the week. The Counseling and Psychology Center requested for \$7,180 while an undergraduate from the Hospitality Department requested for \$500. Those requests will be looked into by the senate Finance Committee on Friday September 23rd 2011.

OPERATION REVIEW CHAIR REPORT

- A- Senator Adekoya informed the senate that the Operational Reviews Committee consisted of Senator Ingabire and Senator Odimayo.
- B- Senator Adekoya also informed the senate that the first Operational Reviews Committee meeting will be held on Thursday September 22nd 2011 at noon.
- C- Senator Adekoya also informed the senate that the different councils on campus will be audited in accordance to the SGA President's request.

STUDENT ADVOCACY CHAIR REPORT

- A- Senator Sanchez pointed that she is working on a survey to find out what students need to see done on the 2^{nd} floor of the WUC building.
- B- Senator Sanchez also pointed out that she is working on finding out what students need to see on the Biscayne Bay campus in general. For example, Microwaves.
- At this moment, Senator Haspel walks into the senate meeting.
- Senator Nonell asks Senator Sanchez on the progress of the bookstore's inability to have all the needed books on campus.
- Senator Haspel states that he is lost on the topic in discussion after being recognized by the chair (Senator Usma)
- Senator Nonell then explains that the bookstore isn't up to date in the book supplies needed by students on campus.
- Senator Sanchez acknowledges that she would look into the bookstore problem.
- C- Senator Sanchez declares a point of information about the budget for water fountains.
 - Senator Usma points out that isn't money set aside for the water fountains in the budget.
 - The SGA Advisor, Mr Rafael Zapata stated that the money for the water fountains can come out of the Senate Discretionary funds but if it costs more

than \$20,000 then the water fountain reformation will have to be shifted to the next academic year's budget.
