IV. LEGISLATIVE REPORTS

A. Speaker of the Senate Report

- Invoice about the Meet Your Dean Event and Budget Allocation were received. The Comptroller would be making a presentation later on.
- SGA recently admitted some interns. Dominica, one of the interns will be shadow each Senator from time to time.

B. Speaker Pro-Tempore of the Senate Report

V. OLD BUSINESS

A. Meet your Dean Extra Funding

VI. NEW BUSINESS

A. Andrew Shantz Appropriation (vetoed)

- President Haspel vetoed the appropriation passed by the Senate for \$660.00 because it was too much for only one student.
- Memo from the president was read.
- Options were to reconsider, overturn the veto and send it back to the committee for further review.
 - Point of Clarification: 2/3 of the Senate are required to overturn a presidential veto.

Senator Honore and Senator Dehaarte walked into the meeting at 3:48pm

 Motion: Senator Ramos Taype moved Andrew Shantz Appropriation to item D on the Agenda.

Senator Adebodun seconded the motion. (passed unanimously)

B. Senate Appointment: Mahfoudh Oubadji Graduate Senator Applicant

- Speaker Odimayo opened the floor for introduction, questions and answers.
 - Motion: Senator Yan moved to appoint Mahfoudf Oubadji as Graduate Senator.
 Senator Morisset seconded. (passed by unanimous acclamation)

By unanimous acclamation, Mahfoudh Oubadji became the new Graduate Senator.

C. Andrew Shantz Appropriation (vetoed) Reinstated

- Point of Correction: Parliamentarian Cohen referred to the Statutes and 2/3 of the Quorum are actually required to overturn a presidential veto, not the whole Senate.
- Motion: Senator Adebodun moved to overturn the presidential veto Senator Hassan seconded.

By a vote of 10/4/0, the presidential veto was overturned and the Appropriation came into effect.

D. Summer Budget / Comptroller Report

- Comptroller Collyer started that the budget presented to the Senate is in regards to an additional allocation during the summer session that the university had.
 - The total amount is for \$70,499.00 in result of additional enrollment that the university did not expect during the summer period between April and June resulting in an excess of activity and services fees that needed to allocate somewhere.
 - First it was allocated to university wide, then it was broken down to campus specific and that was the final money presented to the Senate.
 - That budget happened in June and it should have been passed during the summer, which did not happen so technically, was automatically approved, but still they wanted to still presenting it to the Senate.
 - The budget then was presented with all details and organizations funded.
 - The budget at the moment was already presented to the Vice President of Student Affairs and was waiting for approval.
 - The Comptroller read Section 3.05 subsection a.ii.2.(b).(ii) which states that if "a Campus-Specific Budget not receive a two-thirds (2/3) approval of its respective Senate by the last regularly scheduled senate meeting the original Campus-Specific Budget proposal of that campus shall be adopted.
- President Haspel mentioned that the Speaker was asked to call a Special Session
 after the University-Wide Budget and the Campus-Specific Budget were approved
 during the summer. The Speaker did not do so the probation did apply.
- Speaker Odimayo mentioned that he did try to organize a Special Session but a quorum was not met. And the fact of being in Finals Week, made impossible to have a meeting.
 - Point of Clarification: Comptroller Collyer mentioned that the money was not being approved at that moment; it needed to be approved by the Vice President

of Student Affairs. It had to be signed by both Presidents, both Comptrollers and University Wide and presented to the VP of Student Affairs.

- Motion: Senator Gabriel moved to approve the budget as it stands.
 Senator Morisset seconded
- Senator Ramos Taype stated that this misunderstanding and miscommunication should not happen again.
