Elections appeal taken to SGC-BBC Court

After former presidential candidate Jose Sirven had been disqualified from the SGC-MMC elections on the grounds that he has not held an SGC-MMC position according to the MMC Supreme Court, he is now looking to take his writ to the SGC-BBC Supreme Court.

SGC-BBC's Department of Justice on April 4, has agreed to hear Sirven's grievance against

Sergio Molina, who is the current SGC-MMC Chief Justice on the premise that, according to Sirven, SGC-MMC Supreme Court held evidence for incrimination and did not follow due process. Sirven was notably disqualified on the grounds that it has been interpreted by the SGC-MMC Supreme court that his position of RHA was not in fact a SGA position. He believes that he was wrongfully disqualified by FIYOU and has stated that "Two months before the elections started, everyone knew I

was running. The advisor of SGA asked specifically if RHA belonged to SGA, and the answer was yes."

"We understand that Sirven has grievances against the MMC Supreme Court that he'd like to address. Although we agree that these grievances should be heard, as is the right of any FIU student, we would advise that he do so in a manner that is in compliance with the SGA-MMC constitution, which , as it stands now, would be in the senate," said Molina.

Once elections began

a writ was filed by Juan Gilces. "He basically said that RHA was not a part of SGA. Therefore RHA position is not an SGA position. That they are two separate things," says Sirven. "RHA was created by SGA, I get paid using the official salary fund. I have to attend all of the SGA meetings."

He also shared the his position by stating that "the constitution does not define what an SGA position is, but if you look at the statutes, nowhere in the governing documents he also mentioned that "if you look at the statues, the closet term that can be defined is an SGA official."

According to Sirven "in the statutes it says that SGA official members are of the legislative, executive, judicial branch, or those other individuals identified in the statutes." He claims that in the statutes it states that "RHA is defined as an agency of SGC-MMC, and was created in 1997 by the university student senate."

Sirven claims that the statutes specifically say that SGA official is it defined." However, is ultimately an SGA

position. "The statutes specifically say that the president or director of an agency has to do X, Y, and Z. SGA salary fund is the fund where all sga officials get paid, including senators, and Alexis Calatayud."

Sexual assault case causes discussion

Wednesday, March 30, a former Stanford athlete was found guilty of sexually assaulting an unconscious intoxicated woman outside a fraternity party in a case that put more pressure on colleges across the nation to do more to prevent assaults and punish offenders.

Among those universities, is FIU, whose annual Slut Walk event will once again demonstrate the concept of consent to the community.

"Often times when sexual assault occurs, it's asked 'What was she wearing? What was he wearing? What were they doing?," said Drey Aradanas, president of FIU's National Organization for Women, in an interview with Student Media concerning sezual assault .. "The [blame] is always placed upon the victim and not on the perpetrator and that's something

blazer looked down, and his mother wailed and stomped her foot.

The eight men and four women on the jury left the courthouse without commenting, as did Turner and his family.

Turner, who voluntarily withdrew from Stanford after his arrest early last year, will be required to register as a sex offender for the rest of his life and faces a maximum of 10 years in prison. Judge Aaron Persky set sentencing for June 2. In the meantime, Turner, who had aspired to swim in the Olympics, remains free on \$150,000 bail.

Prosecutor Alaleh Kianerci contended that Turner knew the woman was extremely drunk and purposely took advantage of her. The assault was a crime of opportunity that takes place too often on college campuses, Kianerci said in her closing argument.

"He may not look like a rapist," she said, "but he is the face of campus sexual assault." The verdict comes after campuses across the country drew federal scrutiny for their response to campus safety and the threat of sexual assault in the past two years. At one point, the federal Office for Civil Rights was investigating more than 90 colleges nationwide. Though the Stanford case could be viewed as landmark for sexual assault, at the local level, students at FIU are still concerned about what the University can do to combat the problem on it's own grounds.

Twenty-year-old Brock Turner of Stanford University was convicted of three felony charges: assault with intent to commit rape of an intoxicated woman, sexually penetrating an intoxicated person with a foreign object and sexually penetrating an unconscious person with a foreign object.

District Attorney Jeff Rosen said the case helps make the distinction clear between consensual sex and sexual assault.

"Drunk means no," Rosen said. "Passed out means no."

The jury deliberated for less than two days after hearing both Turner and the victim testify over the course of the eight-day trial. As the verdict was read, the Ohio native wearing a navy

UC Davis students march to pressure chancellor to step down

At least 250 students marched across the University of California, Davis campus Friday afternoon demanding the resignation of Chancellor Linda P.B. Katehi for what they see as ethical lapses in her acceptance of board seats of private corporations. The students, some of whom have occupied the reception area outside Katehi's Mrak Hall office for three weeks now, carried banners with slogans such as "Mrak Under New Management" and "Katehi resignation speech." The campus sidewalks were dotted with "Fire Katehi" written in chalk, and students spent Friday listening to speakers explain that they want the chancellor out.

California lawmakers dominate oversight of U.S. spy agencies

Three disparate California lawmakers lead Congress' oversight of the U.S. spy services, sharing secrets but not the same spin. One is a former San Francisco mayor and the state's deal-making senior senator. Another comes from the rural Central Valley, holding a master's degree in agriculture. The third is a Harvard Law School-trained former federal prosecutor with statewide political ambitions. When terrifying things happen, from Brussels to San Bernardino, these congressional overseers get called. Daily, even when all seems quiet, they must struggle to corral bureaucracies that keep mum about how they spend an estimated \$53 billion a year.

positions." It also explains that the "President of RHA is not considered an SGA position, and that Sirven has had no other SGA position prior to his Presidential candidacy, he has failed to hold any SGA position at all, let alone one for two semesters."

After this ruling, Sirven had said that the justices were illegally confirmed. "We haven't had a court under Alexis Calatayud for the past two years. The only time we've ever had a court is right after FIUYOU filed a writ against me," says Sirven. "A week after the writ was filed they held a senate session, and during the senate session they confirmed three associate justices."

Sirven also noted that "in order for the senate to conduct official business a quorum is needed." He also suggested that "if they need to pass any resolution, or if they need to vote on anything, or to confirm anybody, then the need half plus 1. So say there are 28 senators, even though there are supposed to be 29. [Half] of 28 is 14, so we need half plus one.

That is 15. There are only 14 senators in attendance. They confirmed the justices with only 14 senators."

Sirven also claims that the hearing was held past deadline. "The writ was supposed to be validated on March 8. It was validated on March 9." Juan Gilces was noted to have submitted the appeal to Molina on February 23. "So according to the constitution, the supreme court has 10 days from the submission of the writ to validate it," said Sirven.

Stanford athlete found guilty of sexual assault

how to address sexual assault," said Aradanas.

FIU's Counseling and Psychological Services as well as its Victim Empowerment program addresses sexual assault on campus via lectures, pit events informing students of the services available to them and personal counseling for survivors of abuse.

Services include a variety of help hotlines both online and over the phone, counseling centers on campus, and medical centers.

Stanford convened a task force made up of students, faculty and staff, which late last year recommended ways to enhance the university's educational efforts about sexual assault, increase support for victims and improve its policies and disciplinary processes for reported cases.

Turner was arrested Jan 18, 2015, immediately after two Stanford graduate students who were bicycling by a Kappa Alpha fraternity party about 1 a.m. caught sight of him on the ground outside, thrusting his hips atop an unconscious, partially clothed woman. Outside the courthouse, Kianerci credited bicyclists Peter Jonsson and Carl Arndt for the success of the case and lauded the victim for braving public embarrassment and testifying.

Turner testified that the Palo Alto woman, who was 22 at the time, was awake and conscious throughout their encounter and that he never intended to rape her. testified she was "no more drunk than anybody else" at the party.

Yet shortly before the 1 a.m. incident, the woman had left an incoherent message on her boyfriend's voice mail, Kianerci noted.

Turner's blood-alcohol level was twice the legal limit, but he testified he could walk and talk normally. At the time of the incident, he was a member of the Stanford swim team, but did not belong to Kappa Alpha.

The woman was in tears as she testified that she woke up in the hospital with pine needles in her disheveled hair, dried blood on her hands and elbows and no memory of meeting Turner or being hospitalized.

But Turner said the woman had agreed to accompany him to his dorm room, a mere 10 minutes or so after the two began dancing together and kissing at the fraternity party. As they walked outside holding hands, he said, she slipped and they fell, then started kissing on the ground near an outdoor trash bin. He testified that she said "yes" when he asked her if he could touch her genitals and that he did for a minute. He said he asked her if she liked it and that she replied "uh huh."

He told the jury he then began to feel sick from the seven beers and two sips of whiskey he'd drunk, so he stumbled away. Suddenly, one of the bicyclists came at him for no reason, he said, and he decided to run in fear.

Sugar daddies – dangerous donors

Traditionally, college students would take up parttime jobs or sell textbooks. However, in the recent years, a growing number of students, particularly female, have sought unconventional ways of funding their tuition. Multiple studies have found that female students are using "sugar daddy" services to supplement their income and pay for their studies.

According to The Economist, nearly 75 percent of college graduates are saddled with debt, owing an average of \$35,051. Compared to 1995, roughly half of all graduates carried debt, averaging less than today's third.

With the rise of the cost in tuition rose the number of "sugar daddies," generally older, wealthier men who pursue young women, "sugar babies," for companionship in exchange for money and a luxurious lifestyle. While that's the surface image of the deal, it is often reported

that sex remains unspoken. In 2011, Seeking Arrangement, "the leading Sugar Daddy dating site where over five million members fuel mutually beneficial relationships on their terms," reported that

baby sounds like a simple way to pay for college, it could lead to dangerous situations. Sugar daddy services pitch companionship for money, but the unspoken truth is that sex frequently factors into the equation.

Rather than learning professional habits or skills, a person is learning to trade their charms for cash. Sugar babies are expected to cater to their payer's physical and emotional needs. Particularly for women, many sugar daddies expect sugar babies to include sex in the exchange. Another red flag is that of an imbalance of power in the relationship. A sugar baby is generally younger, poorer and has less power, while the sugar daddy is usually older, richer and has more power.

Both may get what they want, but the sugar baby has to cater to the sugar daddy in ways that satisfy them in order to be paid, therefore making one feel powerless against the other. This type of relationship is unhealthy because it could potentially become psychologically and physically violent or damaging. There is also the potential for sexual assault, sexually transmitted diseases, unwanted pregnancy and more.

While honest, old school ways of making money still have their appeal to some students, there is also a range of other ways students are making money on the side in unconventional industries - with sugar daddy services appearing to be the popular option.

Chaotic campaigns overshadow student realities

It has been three years since SGC-MMC has had a contested elections cycle. While we understand the excitement students have, this editorial board is disappointed in the pettiness that has overshadowed the campaigns.

In fact, the irregularity of this election season is likely the cause for the postponement of SGC elections both at the Modesto A. Maidique Campus and Biscayne Bay Campus. Originally scheduled for April 5 and 6, elections will be held at an as-yet undetermined date.

From allegations of corruption on both sides to defacing campaign materials, this cycle has been riddled with chaos since the announcement of candidates. While this makes for an entertaining elections cycle, these elections should be taken seriously.

The vital role that SGA has previously in student lives has faded. Student issues aren't a means to gain notoriety or a position of power - they're real and deserving of attention and action to resolve them. This fact has been neglected.

Through all that has transpired during the cycle, student issues have been cursorily addressed. SGA should exist to serve students, not itself.

Student media would like to see candidates, as the student-elected leaders of the University, who are involved in student issues more consistently, not just around elections. For example, during the elections cycle, a lot of attention was paid to non-Greek involvement in SGA when student participation regardless of affiliation should be taken into consideration constantly.

We'd also like to see candidates who have a genuine interest student issues and have actionable, detailed plans for either resolving them. Candidates should cease making outlandish and ridiculous promises for the sake of votes. Instead of antagonizing other parties with snide remarks and catty politics, candidates should be focused on actually bringing their goals to fruition.

Furthermore, while students elect the representatives that make up SGA, it's important to remember that bribing students for votes is unethical. There have been countless times when funding has been dangled in front of student organizations as a bargaining tool for votes by both parties. This is unacceptable. Student concerns are more than casual, frivolous insertions in a suggestion box. It's the duty of student leaders to hear, understand and respond to these very real issues, without resorting to dirty politics.

Letter: Reporting on SGC-BBC elections 'blemished with a number of errors'

The SGA BBC Elections Commission Board would like to thank The Beacon for recognizing our efforts in increasing participation for elections and for acknowledging our progression. However, we noticed that the article entitled "SGC-BBC elections still missing options," has construed a few misconceptions and was blemished with a number of errors.

First, the article stated "the only candidate running for vice president is Michelle LaFontant." The candidate's name was misspelled and is actually Michema Lafontant.

In the same paragraph, the article stated that "current Vice President Kenley Jean-Louis was previously listed as running alongside Mejia this election by Student Affairs." According to Section 6.04, Heading (a), Subsection (vi), Subsection (3) of the SGA Elections Code, "Individuals running at BBC shall run for President and Vice-President separately." Therefore, Jean-Louis and Mejia wouldn't have been able to run together. The article says students have a choice "between two candidates for SJMC Senator, either Sudyen Navarrete or Marquele Brown, after the disqualification of Zainab Osazin." Since there are only two SJMC senate seats to begin with, both candidates should be voted into those seats. The article states that "neither Osazin nor Jean-Louis could be reached for comment regarding their drop from the elections." Jean-Louis said that he spoke with the Beacon reporter, Sam Smith,

on March 29 regarding elections. His reason for withdrawing was that he was graduating and

'Batman v Superman: Dawn of Justice' may leave audiences underwhelmed

Especially in favor of two superheroes hashing it out in the name of comic fanboy dreams coming true.

Last month saw the release of the long awaited showdown between the two biggest names in superhero history: "Batman vs Superman: Dawn of Justice."

It also brought us the first ever film to include Wonder Woman in a theatrical release ever, a very blatant presence in the film.

The release of the movie brought us our first introduction into the real Extended Universe's DC direction to combat the Marvel Cinematic Universe - teasing us with Aquaman, The Flash and Cyborg.

But this isn't about the upcoming Justice League movie. This isn't even about Wonder Woman's upcoming first solo gig on the big screen - noting it's also the first

ever solo film for a female superhero. This is about the general consensus that Batman and Superman's brawl left people underwhelmed.

The truth? The movie is trash. Does that mean it wasn't enjoyable? Heck no.

In all honesty, its bleak, dark, and edgy overtone and atmosphere - while it does set up a more realistic approach to superheroes in a modern-day setting - becomes overbearing after a while.

Coupled with the fact that while writing Clark Kent/ Superman as a superhero who still feels lost in a world that fears him is a great idea, undercutting his more optimistic personality leaves so much more of his character to desire. It does make him a bit flat.

But it doesn't mean his character is poorly written, just missing an essence of the Superman we're all familiar with.

The pacing was also glaringly slow and felt as though it dragged at certain parts.

It includes dream sequences designed to set up the internal conflicts within both titular roles that come off as too long and unnecessary to the core narrative.

In the case of Bruce Wayne/ Batman, we only needed the flashback to "Man of Steel" at the beginning of the movie and we already get the picture: he doesn't like nor trust Superman.

What should've been more screentime devoted to developing Superman as a more interpersonal, rational and open person is given to emphasize over and over that Batman is a skeptic - i.e. information we already had going in.

All this being said, entering this movie knowing you're only going in anticipating each superhero clobbering the other half to death for amusement (and maybe for Wonder Woman showing up and dragging them both by the ear to time out) is really the only way to watch this movie.

At least, to watch it and walk out impressed. What you'd expect as just a superhero deathmatch, provides you with something actually worth engaging in.

The movie sets itself two years after the events of "Man of Steel," in the wake of the destruction caused by Superman's battle with General Zod and his Kryptonian army.

In this destruction, a Metropolis location of Wayne Enterprises is brought down and Bruce Wayne carries this weight with him, as well as the weight of his now 20-year

vigilante career.

The Batman is a little different than we'd expect him to be - hardened, his faith in himself wavering, but more importantly he is excessively violent.

His methods, including branding his targets and being lenient on his no-gun rule, catches Superman's attention. Eventually, the Man of Steel crosses paths with the Dark Knight in a not-so-friendly warning to stop being a vigilante, which doesn't blow over well for Batman.

Eventually Batman does the one thing he can think of: find out exactly how invincible Superman really is. The first place he looks to is, not so shockingly, Lex Luthor, who's found a mineral left behind by Zodd's ship that causes Kryptonian cells to degenerate and die out.

Meanwhile, a woman named Diana Prince (Wonder Woman) who is also looking into Luthor for her own reasons grabs Wayne's attention once she interferes with his covert, vigilante detective operations.

It becomes clear that Luthor has something big planned with this mysterious mineral - but the real question is what happens when Batman gets his hands on it?

Contrary to what many would say, the acting was wonderful. The best players vying for their scenes were Jesse Eisenberg's trulv psychotic Lex Luthor, Ben Affleck in his rendition of both Bruce Wayne and Batman and Gal Gadot bringing Wonder Woman to life on the big screen.

It also had amazing cinematography and art direction, especially for a superhero flick.

One of the most consistent, negative comments is its "poor structure." Many reviews that defend the movie comment that it is structured similarly to how a comic book would be, which is actually consistent.

It displays itself, formally, as a revitalized comic book adaptation of several Batman and Superman graphic novels.

In respect to keeping this spoiler-free I won't say which ones, but it's apparent all the way through that this movie wasn't designed to present itself as a Hollywood remake,

but a superhero movie made out of pure fun and personal direction.

As a film that wanted to be a superhero movie that, sure took itself a tad too seriously, but at least wanted to dip its toes into comic book lore for a fun ride, "Batman v Superman" is a great experience.

If you go in expecting divine, awe-inspiring а cinematic experience, you will be disappointed. Even expecting it to mirror Marvel's endeavors - even partially, will leave you underwhelmed.

Enjoy it for what it is, not what it could be. Dislike it because you just don't like Zack Snyder's direction with the story. But don't go in with high expectations; It's a disservice to the movie itself to place so much make-or-break blind faith onto it.

"Batman v Superman: Dawn of Justice" is now playing in theaters.

Panthers take down the Knights in season finale

The women's tennis team found chinks in the University of Central Florida Knight's armor to win their final match of the season in Orlando on Saturday, April 1.

The Panthers (15-2) came back from a 2-0 deficit to down the Knights. The Panthers won four out of the 6 singles matches to clinch the match.

Saturday's win over the Knights improved the Panthers' away record to a perfect 8-0.

The Panthers improved to 4-2 when losing the doubles point and remain

undefeated when winning the first point. The Knights jumped ahead early and took the doubles point.

The duo of freshman Maryna Veksler and junior Nina Nagode dropped their match, 6-2, to Natalia Serrano and Sofia Baptista.

However, senior Carlotta Orlando and redshirt freshman Andrea Lazaro evened the doubles match.

The pairing defeated Emilia Granstrom and Caroline Eberhart, 6-3.

The Knights took the last doubles match, as senior Kaitlin Brozovich and sophomore Nerma Caluk lost to Monica Matias and Cortney Cesarini 6-3.

The Knights added to their lead in the singles portion of the match as Brozovich

fell to Serrano in straight sets, 6-0, 6-1.

The Panthers' first point came when Lazaro picked up her 16th-straight win with a 6-1, 6-3 win over Granstrom. Lazaro remains undefeated in dual matches.

FIU tied the match at two when Orlando defeated Cesarini in straight sets, 6-4, 7-6 (4). The Panthers took the lead, 3-2, when Nagode defeated Baptista in three sets, 6-7 (1), 6-2, 6-2.

But, the Knights tied the match at three when Veksler fell to Eberhart in three sets, 2-6, 6-0, 6-4.

Caluk clinched the match for the Panthers, 4-3, when she defeated Matias in the final set, 7-5, 0-6, 7-5.

The Panthers were scheduled to play the University of Alabama at Birmingham

Blazers on Sunday, April 2, but the match was cancelled because of inclement weather. The match will not be made up.

If the match against the Blazers was played, then the Panthers had to win against their conference opponent to clinch the No. 1 seed.

However, since the match was cancelled and FIU has the lowest ranking in the conference and best conference record, the Panthers clinched the No. 1 seed. FIU will travel to Murfreesboro, Tenn. to take part in the Conference USA Tennis Championships from April 20-24.

The Panthers head into the tournament as the No. 1 seed in the conference.

short, four game road-trip at the University of Texas at San Antonio, winning two out of the three games against the Roadrunners of UTSA and three out of four on the trip, with their defeat of the Bethune-Cookman Wildcats 21-8, while hitting five home runs as a team.

It would be tough to replicate the offense that FIU displayed on Tuesday, March 29, at Bethune-Cookman.

Their attempt to at least resemble what they did against the Wildcats, against the Roadrunners of UTSA would be nothing more than that.

Seven hits as a collective was a weak showing for a team and below the norm for this offense. It wasn't all bad for the entire FIU team, as catcher Zack Soria had a great day at the plate again, batting .324 on the season and accounting for three

FIU starting pitcher Garrett Cave (2-2) would give UTSA plenty of opportunities to score, walking six batters, but with four strikeouts, as well as only allowing three hits in his five innings, they could only gather two runs against him.

Those two runs didn't come until the end of Cave's start and would be just the motivation the Panther offense needed to get things started.

The FIU offense would post seven runs in the sixth and seventh inning, with a Rey Perez two-run double coming in the sixth and in the seventh an Eddie Silva RBI single and a home run from right fielder Kenny Meimerstorf.

Nick Day would hit a solo home run to help the cause in the top of the ninth inning, putting what seemed to be the dagger in the side of the Roadrunners and the exclamation point on the road trip with FIU's 11th hit on Sunday.

UTSA made one last run at the win, scoring two runs in the bottom half of the ninth inning on two run single, but FIU sophomore Williams Durruthy would get out of the jam with his team leading third save of the season, the game's final score 8-4.

Soria, like four other runners was left on base twice, as 15 runners were left on base on this Friday night for the Panthers.

Right hander Andres Nunez (2-2) could have used at least one of these runs, if not four, to combat the four runs he gave up in his start.

In one of his longest starts of the season, he went seven innings.

The Roadrunners had no plans of laying down to the defending CUSA Champs and they scored three runs of their own in the bottom half of the inning, knotting the game up at

h three and virtually taking everyone back to square-one.

FIU and UTSA would exchange runs again in the third inning and the score would be 4-4 going into the top of the fourth inning.

With no outs, an RBI double from third baseman Eddie Silva would put the Panthers up by one run. Nick Day would follow that by keeping his great day going and hitting a sacrifice fly to score second baseman Rey Perez, and make the score 6-4 FIU.

Those four runs for UTSA were all that Chris Mourelle(4-2) would allow on Saturday, April 2, in yet another mostly dominant start, striking out as many batters as hits, with six.

The next inning, the Panthers

Both teams desperately needed a win to at least draw closer to even and they played like it.

The Roadrunners, technically in a worse position than the Panthers, put a couple runners on base in the first to try to jump out to an early lead. The Panthers will have a chance Friday, April 8, to win another game against a C-USA team and even their record in Conference USA at 5-5 when the Old Dominion University Monarchs visit the Panthers in Miami.

They'll play another game on Saturday, April 9, and finish their three-game series up on Sunday, April 10, before Bethune-Cookman University makes the short trip south from Daytona to try and redeem themselves after giving up 26 hits and committing three errors against the Panthers.

P THER PROFILE Naomi Ruele continues to make her mark

Since the graduation of Jerica Coley, Panther fans have been devoted to finding a new star to get behind here at FIU. Replacing the greatness that was "Holey Coley" is no easy task, but if anyone can live up to the challenge, it's a 19-year-old Olympian.

Redshirt freshman Naomi Ruele is a swimmer for the FIU swimming and diving team. Because the swimming and diving team is not one of the "big three" sports, football, baseball or basketball, it seems that the successes of this team and several others here at FIU are constantly overlooked. Naomi Ruele was born in Gaborone, Botswana, relatively mid-sized а country located in the African continent, bordered by South Africa to the south, Zimbabwe to the northeast and Namibia to the west and north.

The African nation is home to just over two million inhabitants, very few of which are swimmers. So how does a young athlete from Botswana get into swimming?

Ruele said she competed in many sports at a young age, but it was swimming that stood out to her and which she really excelled at. The strong relationship Ruele built with her swim coach, she said, ultimately was one of the biggest factors that led her to pursue the sport.

"I went into a lot of sports, track and netball, but I really liked swimming and I got along very well with my coach. He wanted to bring me closer to the sport and I really believed in his vision."

Swimming with the Panthers this season, Ruele took home seven first-place medals at the Conference-USA championships. As great as that sounds, it sounds even better knowing that seven events is the most an athlete can compete in at the C-USA games. Ruele did as well as she possibly could given the rules of the tournament, going home with a winning percentage of 100.

"Going into the Conference tournament, we were not ranked first in most of our relays, so we did not expect to win them all. I can't say I expected to go seven-for-

seven but I was so happy when it happened," Ruele said. "It showed how all the hard work has paid off."

The relays Ruele spoke of are the four relay events she swam with her teammates, whom she did not fail to credit.

"A lot of my success I credit to my teammates. I would never have gotten this far without their support and of course their performances alongside me."

Along with her teammates and coaches, Ruele credits most of her success to her family. Specifically, her mother, who Naomi says, "sacrificed so much for me. I am so grateful for her and everything she has given me. And my brother who always supports me."

Seven gold medals and C-USA swimmer of the tournament in 2016, multiple school records which she broke swimming for the Panthers this season and an appearance in the NCAA Championships are all defining moments for the native of Botswana; however, none come close to what she says is the most memorable of her career thus far.

"Qualifying for Rio 2016. Definitely," said Ruele, with an affirming head nod and giant smile, which is expected coming from a 19-year-old who just a year ago was sidelined due to a shoulder surgery.

Ruele will be swimming in the official Olympic games this summer, representing Botswana. Only one athlete has ever medaled while representing the African nation, 800 meters silver medalist Nijel Amos four years ago in London.

By recording a time of 26.07 during an official Fédération Internationale de Natation (FINA)



approved time trial, Ruele will have the chance to become the first even woman medalist for her native country of Botswana and only the second ever.

"I'm really excited. My initial goal was just to make the Olympics so now that I have done that, I can shift my goals to different aspects these next few months," Ruele said. "I am excited to be able to compete for Botswana and it would be a huge feat to bring home a medal."

Prior to FIU, Ruele competed in the South African games and the Youth Olympic games in Nanjing, China, which she says will surely help her in preparation for the Rio 2016 games.

"Nanjing was one of my first international competitions, and was very overwhelming," Ruele said. "It taught me a lot that so much goes into being at the top. There are so many sacrifices that must be made and I now know which sacrifices I have to make. It was a learning experience, for sure." Ruele made sure to mention that her performance at nationals is something that should be noted as she works towards preparation for the Olympics. Naomi placed 51st at the national tournament this year representing the Panthers, swimming in the 50 free prelims.

As far as her time in Miami, Ruele notes that Wynwood is her favorite part of the city. "I love Wynwood, it is so much fun." Naomi did not deny that adjusting from Africa to the United States was not easy, but that it was only a matter of time before Miami was a second home to her. Maybe it was the pools here, or maybe the Cuban food.

"I really loved fried Plantains. Those are bomb," Ruele said. "I also tried fried Oreos for the first time a few months ago and they are now my favorite American food and easily the greatest thing I have ever tried. I could eat those every single day."

The most surprising part of the interview was when Ruele insisted that Miami summers trump anything Botswana has to offer. "The humidity here is crazy. It is so hot," Ruele said. "I tell you, Africa is hot, but not this hot. Summers in Miami, Wow. They don't compare."

One thing is certain, If Ruele continues to swim this well, she will have no problem staying cool this summer.
