# Regent critical of students

A Florida regent who voted not to confirm Ron Arrowsmith as vice president for administrative affairs, is appalled at the lack of knowledge among students regarding government and the university system.

"It's unbelievable that senior students know little or nothing about the Board of Regents, or laws that affect the university," said Marshall Harris, one of the nine Florida regents, in a recent phone interview.

"I'll be glad to go to FIU and hold a meeting to instruct students on the functions of the Board," he said.

Harris voted against Arrowsmith, in a Pensacola meeting of the Board, because

he lacked evidence of Arrowsmith's ability to do the job.

"I was not aware that the issue would come up at that meeting and I had no information as to his job performance in his previous position. However, I know that a good search and screen procedure has not been done," he said.

"The fundamental issue is to get the right person for the job and I am concerned about his adequacy. I have not been given enough time to look over his records, but I intend to do so."

He assumes that Arrowsmith will be appointed Vice President for administrative affairs at the next meeting of the Board that will be held in about 30 days.

"I feel the current rule, where regents appoint the vice presidents is wrong. The person that makes that decision should be the president," he said.

Harris, an attorney, feels the Board is doing all it can to raise the quality of the state's university system.

"The problem is a question of priorities. Florida not only supports the university system but also a program of rehabilitative serves and care of indigents or wards of the state. A state like Alabama is very proud of their University of Alabama football team and their tuition rates are lower than ours, but their rehabilitative services stink," he stated.

Harris served in the state legislature for eight years, four of those as chairman of the appropriations committee.

# Election Crisis Continues

A newly-created Student Government Association judiciary committee will meet Friday to review the SGA election committee's rejection of Jose Eiriz's contest of the recent SGA elections.

After three days of hearings, the elections committee ruled last Friday that, although there were infractions of the elections guidelines, none were willful, or serious enough to invalidate the election of H. Clayton Hamilton as SGA chairman.

Hamilton, however, is unable to assume office until Eiriz has exhausted his appeals through the elections com-

mittee, judiciary committee, and the SGA senate itself.

Originally, Eiriz had protested the entire election, but the senate, meeting in special session Tuesday, ruled that a candidate could not protest a contest in which he was not engaged. Thus, only the chairman's seat remains in dispute. Under this ruling the SGA was able to seat all senate members certified as elected in the spring election and the run-off.

The new members took their seats Wednesday, following a decision by the then-senate to seat the new members immediately. It was the newly constituted senate

which voted to establish judiciary proceedings.

Eiriz, who had expressed his desire to appeal, was not present at either Tuesday's special meeting or Wednesday's regular SGA meeting.

Eiriz was a poor third in the spring election, polling a mere 104 votes, about 10.8 percent of the total.

Hamilton and Pedro Prado battled neck and neck, forcing a run-off when neither received the required majority in the first election.

Hamilton won the run-off. Prado bowed out gracefully, giving his best wishes to Hamilton for fighting a clean, hard battle.

## Is chair seat vacant?

Is the SGA chairman's seat now vacant? Only Jose Eiriz's absence from Wednesday's senate meeting kept this question from being revealed.

Chairman-elect H. Clayton Hamilton is unable to assume his duties until outgoing chairman Jose Eiriz's contest of Hamilton's election is resolved.

But the SGA Constitution appears to say that Eiriz's term ended with the election of Hamilton. The constitution

states: "Term of office for Senate members shall be for one (1) full year and until a successor is elected."

Hamilton was elected. Eiriz contested the election, and the election committee ruled Hamilton's election valid. The commission has refrained from certifying Hamilton's election only because of Eiriz's appeals.

In the absence of the chairman, the associate chairman assumes all duties and powers of the chairman. The newly elected associate

chair, Evan Gonshak, appears to be in a very crucial position. He chaired Wednesday's meeting.

If Hamilton is not quickly certified will Gonshak or Eiriz continue as chair?

Eiriz has requested that the election be invalidated. He hopes this will permit him to continue as chairman, at least until a new election.

But because the election committee refused to invalidate the election Hamilton remains the chairman-elect.

## Legal Notice

The Student Government Association Judiciary Committee will meet Friday, April 29, in University House 213 East, at 12:30 p.m., to review complaints by Jose Eiriz contesting the recent SGA elections for Spring 1977. All interested persons should attend.

The committee will serve as an appeal body to review the findings of the election committee, which ruled that complaints by Eiriz were not grounds to invalidate the election outcome.

## HEW funds student project

In 1973, a group of FIU students in Dr. Marvin Dunn's Community Psychology class were assigned to write a grant letter to the federal government.

They asked for a half million dollars to fund a new, remedial community organization.

A short time later, the Department of Health, Education and Welfare awarded the group \$380,000 from the Emergency School Aid Act (ESSA) to design a program "focusing on the elimination of minority group isolation among area secondary schools."

The grant came as a surprise to Dr. Dunn, who said he "didn't expect anything to become of it" when he gave the assignment.

The ESAA grant began the framework for CHIC (Cultural Human Interaction Center), now under the direction of Dr. Dunn and FIU's Psychology Department, but whose beginning is largely attributed to the 15 or so students who were the inspiration and voice for CHIC in 1973.

"I can't stress enough how it was the students who got CHIC going," stated Dr. Dunn.

CHIC is now entering its fifth year, and has since been expanded by the awarding of two additional grants; one from HEW, and one more recently, from Dade County.

The ESAA program began with two (since cut back to one) CHIC facilitators working with a group of racially mixed students in one of six area secondary schools.

ESAA's purpose was to improve racial relations and understanding among black, white and Latin students with a focus on developing the student's self-awareness;

communication skills; understanding each other's feelings; behavior and problems; and solving and decision-making skills.

In 1973, six public secondary schools, (five in Dade County and one in Broward) began participating in the ESAA program on a yearly basis. The program has been so successful that the HEW has continued to fund it for the past five years. Dunn estimated that 3,000 students thus far have participated in ESAA.

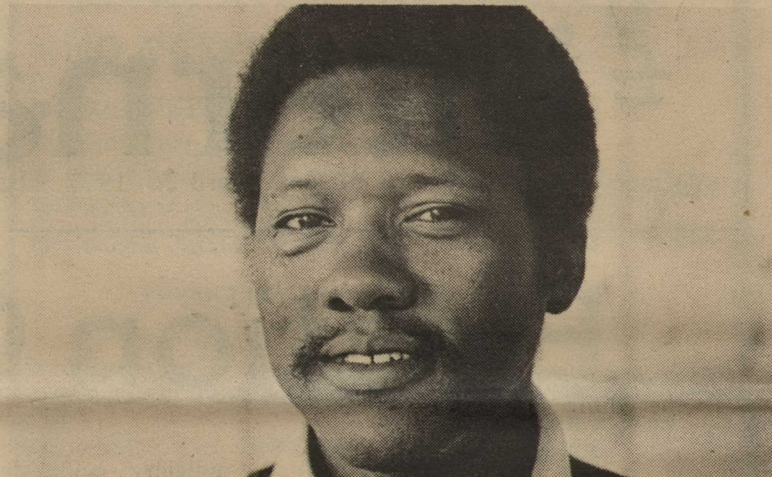
High schools initiating the ESAA program are chosen by a cross-selection of location, student race ratios, and the previous record of racial incidents at the school.

Since its beginning, the ESAA has improved the involved students' attendance records and general attitudes about themselves and each other.

A second grant, Title IV,

was granted to CHIC for 1973-74, and was designed to remedy problems concerning sexism and race relations among county schools' personnel. Some 120 teachers and administrators from all teaching levels met at FIU for seminars, workshops, and meetings with leaders of various women's groups to try and work out conflicts or improve outdated, misguided methods or attitudes.

Most recently CHIC was awarded a contract with Dade County to begin a Crime Prevention program, involving delinquent youths from the Coconut Grove area. The program will involve youths between the ages of 14-17 who have a previous criminal record, and will be aimed at working with the youths psychologically, and "teaching them how to cope," explained Dr. Dunn. "The youths will also be involved in organizing an entertainment center for all

young people of the area."

Each program initiated under CHIC is run and directed by different CHIC staff facilitators, varying in number over the years from 12 to 23. Several CHIC facilitators are FIU graduates, some of whom were involved in organizing CHIC in 1972, and who are now employed under it. In the future, Dr. Dunn

hopes to employ more FIU graduates and possibly students who would work on a part time basis. Besides their work in human relations within the selected high schools, CHIC facilitators are urged to participate in special presentations shown to students not involved in the ESAA groups, and to become involved in outside community programs.

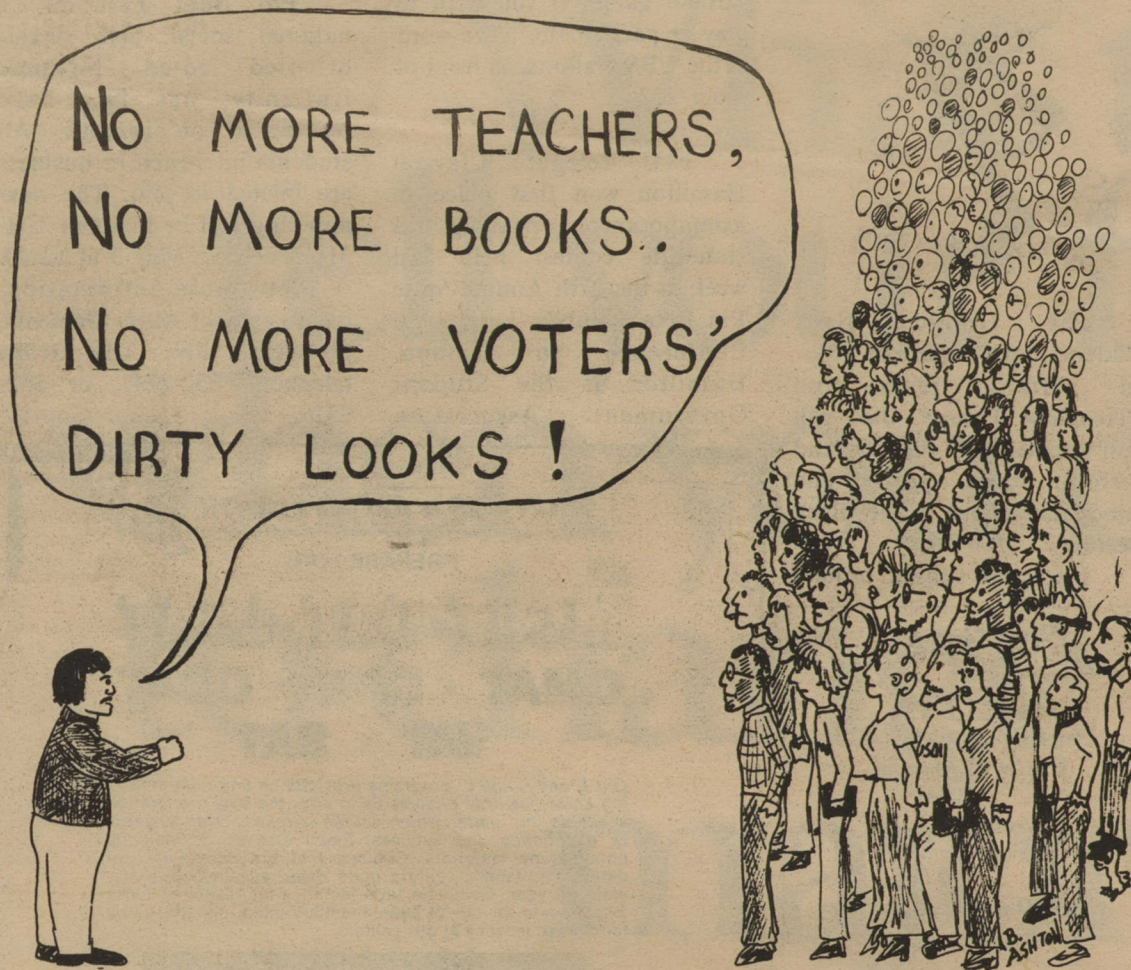

## At Last! A Few Kind Words

At last a small measure of praise for the student government senate which appears to have acted in a sound fashion on the problem of standards for senate pay.

As recently as last week, the SGA emolument committee appeared determined to pay lame ducks for the full quarter despite the fact that they would only serve the first few weeks of the quarter. The committee also opted at that time to pay full pay to the incoming senators who will serve out the rest of the term. That would mean one senator for the price of two.

But, in Wednesday's senate meeting associate Carlos Romero from the College of Arts and Science, who had previously supported the "pay everyone" plan, reversed himself and presented a pay for work proposal.

Under this proposal senators will be paid for meetings attended, or rather will have pay cuts for each meeting missed. So instead of getting \$300, outgoing chair Jose Eiriz will get \$120 for the spring quarter.

The senate accepted the new proposal, and will use it to determine pay for this quarter while work continues on new emolument guidelines. We hope the new guidelines continue with the idea of pay for service and not emolument for rank.

While we are saying kind things about members of the senate it is time to say a few kind words about Dennis Scholl. We were very rough on Scholl when he wanted to collect pay for the winter quarter, when he missed almost every meeting. To our discredit we were not equally strong in commending Scholl for refusing the full emolument. Good show, Dennis.

And lastly to Dennis DeToro, our oft beleaguered elections commissioner. We have disagreed with DeToro and feel that his manner of dealing with the Eiriz qualification questions have largely been partially responsible for the current unfortunate situation of a chairless SGA, and impending court struggles.

But all of DeToro's actions appear motivated by a basic desire for fairness, and in his dealings DeToro has demonstrated a willingness to struggle in the public interest. Student government is a learning experience, and Mr. DeToro has learned a great deal.

## Senate Pay -

To the editor:

I am an SGA senator elected by the students of Arts and Sciences last September for a one-year term. I feel that I have a right to be heard by the students on the editorial page of this newspaper since I was the only impractical voice that defended this newspaper's right to publish the news as it sees it (when the senate discussed and passed a resolution cancelling the contract with The International because in its exercise of the sacred right to freedom of expression it inconvenienced many senators).

This is why, when unethical and partial editorial appeared on April 21, 1977, and before on April 14 made accusations against the entire senate for first retaliating against this newspaper, and on April 21 of giving away money to "lame duck" senators, I

decided to request to be heard in same space as the one used to spread such falsehoods.

First, to reply to your April 14 editorial, I will state that not all senators voted to cancel the SGA advertisement in this newspaper, and that the issue was amply discussed and argued and will be again brought forward when the newly elected senators take office.

Second, as chairperson of the emolument committee, I want to make clear that none of the committee members are "lame ducks," but the committee had to follow the laws of the State of Florida that specify that legislative action cannot be retroactive.

Since the emolument guidelines had been revoked in the last SGA meeting of the Winter Quarter and the senate had failed to approve new guidelines this quarter, all the

emolument committee could do was to follow the only senate law that was still in effect, which specifies that each senator receive emolument for services rendered in an amount equal to 15 hours tuition.

The so-called pattern in which the senate members vote not for the students' best interest is another piece of journalistic misinformation, for ethical journalists would have stated "some senate members," and then named them, instead of casting a shadow upon all of us.

Why don't you publish a voting record? It will show how we voted.

Why don't you publish specifics instead of slanderous

generalities that include senators who, like myself, have fought long and hard for the students and for your right to freedom?

To introduce executive management to the minicomputer, a specialized half-day seminar will be given at Florida International University.

The minicomputer, a product of the miniaturization evolution that has been taking place in the continuing refinement of the general purpose computers, is ideal for taking care of a business' sales cycle, including entry, invoicing, inventory control and sales analysis; handling accounts payable and accounts receivable, general ledger, balance sheet and income statements.

Those who wish to attend the seminar are expected to have a broad general business background, but need little or no data processing experience.

The participants who complete the seminar will be awarded .4 Continuing Education Units (CEU's) by FIU. CEU's are recognized nationally as a permanent record of participation in non-credit continuing education.

The seminar, which is being sponsored jointly by the School of Business and

Organizational Sciences, the Department of Conferences and Short Courses, FIU and Peat, Marwick, Mitchell and Co., will be held Wednesday, May 4, at 1:00 p.m. at the Tamiami Campus in University House room 210.
