# 'F' grade for FIU

## Reorganization plan also approved

Several issues involving Florida International University were acted upon by the Board of Regents in their monthly meeting held June 13, in Tampa.

The BOR approved the return to the "F" grade instead of the present "no credit" grading system that FIU now offers. In 1976, the "no-credit" system was implemented, and the university was asked to carefully monitor the program. The University

recommended the return to "F" grade usage.

The re-organization plan presented recently by President Harold Crosby was also passed by the Regents.

In other actions, the Board ap-

proved a lease agreement between FIU and International Conference Center of Florida, Inc. to build a conference center at the North Miami campus.

The next BOR meeting will be held on July 22, in Jacksonville.


Sanchez, exhibiting paintings and prints, describes a good painting as a remarkable feat of organization.

**"EVERY PART** of it is wonder-


ful in itself, because it seems so alive in its share in the making of the unity of the whole, and the whole is so definitely one thing," Sanchez said.

## Low-cost dental health plan for preserving students' teeth

Due to tight budgets and the ever-increasing costs of medical care, many students are not able to afford proper dental care. The Student Government Association is endorsing a dental health plan to begin in the fall which would provide preventive dentistry to students on a voluntary basis and at a low cost.

Under the dental plan, provided through Dental Health Services, a non-profit corporation, students would pay a \$30 annual premium and dental care would be available at participating dental centers in Dade County.

**SERVICES** such as office visits, x-rays, examinations, teeth cleaning, and fluoride applications would be provided to the subscriber at no cost. Tooth extractions would cost \$8 and a filling would cost \$7. Other more elaborate

procedures would also be provided at a reduced cost.

According to Bruce Friedlander, representative of Dental Health Services, the plan is specifically associated with preventive dentistry and good oral health. He said this plan would make dental care available to students "at a bargain."

The dental plan, which is strictly voluntary, will be made available to students at the beginning of the fall term. A one-year contract with the student would be established, and if the student graduated, coverage would be continued through the length of the contract.

Clayton Hamilton, Chairman of the SGA, said that he feels the proposed plan will be of maximum benefit to students. "We hope this will be the first of many services that SGA will be able to provide to students," he said.



## SGA receives more money

After operating for close to two months with little money, the FIU Student Government Association has received \$15,000 in additional funds.

The money was released by President Harold B. Crosby from the SGA's 1976-77 reserve.

The release came after weeks filled with confusion. The SGA passed a resolution on April 20, asking President Crosby to release the money, accumulated from unexpected tuition fees. SGA Comptroller Martha Gasset said the original budget request, submitted before she took office, was incorrectly done. The offices of the President and of Dean of Student Services Sandra Clark, could not act on the request until the proper procedures were followed.

Eventually, the procedural problems were resolved. Crosby authorized the release of the \$15,000 and wrote a letter to Gasset, explaining that only \$9,935 was for immediate use. The other \$5,065, Crosby explained, was to be used only for "emergency needs of a special nature." He said that public hearings must be held if the emergency funds are earmarked for non-emergency needs.

## Students to be heard at SGA forum meeting

# Chickees to separate students from guests

Recently, students have observed a rather unusual addition of four Indian-style chickees, grass huts, in the visitors' parking lot. Curiosity has sparked as to the purpose of the chickees, and why they were constructed in that particular area.

Dan Negas of the Physical Planning department at Florida International University told the International the chickees are to provide a place for people to relax and cool off. When questioned as to why the visitors' lot was selected as the site for such structures, he responded, "they serve as a dividing line between the visitors' lot on the south, and the students' lot just north of that." He also stated five more shade spots are under construction. These are located between the new Owa Ehan building and University House, on the north side of the lake.

**TOTAL COST** of construction for the nine chickees is approximately \$11,300, according to Herman Dankers of the Architecture and Engineering department.

The location of the visitors' parking lot has been a bone of contention for FIU students for quite some time. Since it is the parking lot closest to the campus buildings, the reason for selecting the area for visitors has been a questionable one.

Negas replied by saying that when the university has guests for seminars and meetings, it is much easier to have them park as close to the buildings as possible. "This way, there is less confusion for the visitors in trying to find their way around," he said.

**THERE ARE** no plans for parking facilities to be built closer to the buildings for students at present. Negas did say, though, that an extension of the lot adjoining the visitor lot is being planned.

## Religious schools needn't fear God or judicial system

Of the many opinions I have heard about the "Metro Gay Ordinance," the most heated feelings were directed towards the employment of Gays in religious schools. Religious educators feared that Gay instructors would describe their private life and instill an approval of their lifestyle in the students (children). They also feared that, when they fired a Gay teacher for this, they would be brought into a legal battle which would be lost--thus forcing them to rehire the instructor who taught contrary to their moral values.

**THESE ARE** all unfounded fears. All the religious schools have to do is draw contracts which state that the teacher is subject to permanent dismissal if he or she strays from the planned syllabus and established morals of the institution. The religious community cannot see this. They fear and have no faith in

the American judicial system--or, they have no faith in God!

This country was founded on principles which guarantee individual rights. Church and state have been profoundly separated to insure that government is operating purely and unaffected by outside forces, other than "the people," which may tend to instill fear, confusion, and ignorance.

Hiring of a Gay in no way interferes with the freedom of religion. Also, most importantly, we cannot allow religion to interfere with individual human rights and freedom--remember the Middle Ages!?





If the goal of FIU is to achieve national reputation of excellence, together with a high-quality academic curricula, our graduates deserve to take with them memories of respect and dignity accorded them at their most important achievement, graduation.

## VETERANS NOTICE

**DURING THE PAST** few months the Veterans Administration has implemented new regulations concerning veterans receiving educational benefits. The primary purpose of this notice is to clarify information put forth in the Veterans Newsletter, Volume IV-Number 3, Spring 1977.

**SINCE PUBLICATION OF** the Veterans Spring Quarter Newsletter, the Veterans Administration has changed regulations concerning payment for NC grades. Now the Veterans Administration will pay for NC grades only if there are mitigating circumstances leading to the receipt of this non-penal grade. Instances such as a death in the family, hospitalization, and relocation of employment may be considered mitigating circumstances by the Veterans Administration.

**THE NEWSLETTER ALSO** reported that the VA Clerk would ask you to fill out a form stating the reason pertaining to a DR, IN, or WI. Although you may include the reason on the back of the certification card, the VA Clerk will only report the date and change of status to the Veterans Administration. Veterans must report reasons or mitigating circumstances directly to the veterans administration.

**A VETERAN WHO** attends the Summer Quarter, pre-registers for the Fall Quarter, and shows proof of pre-registration to the VA Clerk, should experience no delay in receiving checks for the Fall Quarter. A veteran who fails to comply with all of the above and registers on Change Day or thereafter, will have his certification sent to the Veterans Administration at that time and thus should expect a delay in receipt of the first check.

**FOR FURTHER CLARIFICATION** do not hesitate to contact the Office of Veterans Programs & Services in UH 340 or the Office of Admissions and Records in PC 130.

## 'Exorcist Part II': sequel bombs

Very few sequels ever match the movies they follow. The case of 'Exorcist II: The Heretic' is a perfect example.

The movie is weak and the script makes no sense. It ridicules the original movie by calling itself 'Part II' when in fact it is not.

The film does follow the original character of Reagan McNeil, played tolerantly by Linda Blair, but what it does not follow is the logical trend of suspense achieved by the original 'Exorcist.'

Part II is a cheap try to cash in the success of the original 'devil movie.' But that's all it is, a cheap try. So much for the good points.

The acting in the movie is short of horrendous with the exception of Louise Fletcher, who this time is Reagan's doctor. She is best known for her role in 'One Flew Over the Cuckoo's nest.'

Richard Burton's acting is far below the actor's usual fare, but who could blame him. The part of the new exorcising priest probably seems as disgusting and shallow to him as to the audience.

If a really fair chance is going to be given to the movie, viewers would have to forget the original and classify this film as a monster film instead of putting it in the suspense category the original is in.

The special effects as well as the make-up cannot and do not help pull the film from its misery. Not even the devil could save this film from being a disaster film.

The movie does have a few moments of suspense but it fails to keep this mood throughout the story.

After sitting through almost two hours of amateur movie-making, it leaves a doubt in my mind whether the devil really made them do it.

# 'Star Wars'

Sci-fi film flies high at box office


Having almost equalled the box-office success of 'Jaws' the latest Lucasfilm production of 'Star Wars' seems headed the way not only of 'Jaws' but also of a close relative: '2001: A Space Odyssey.'

The one factor in the success of '2001' was the mastery of special effects. Needless to say the techniques used years ago in '2001' have been refined and 'Star Wars' takes full advantage of the high state of the art.

The movie's quick pace follows the adventures of two robots, Seetrepio (C-3PO), a golden armored and well mannered android, and Artoo-Deetoo (R2-D2), a small brightly colored unit which stumbles through the film on its three wheeled-legs. They are a thinly disguised version of Laurel and Hardy. Their antics give the film its best moments of comedy relief.

When the movie opens we find the spaceship carrying Princess Leia, Carrie Fisher, has been captured by a vessel commanded by Darth Vader, the Dark Lord of the Sith and one of the most powerful men in the Galactic Empire, the meannies of the plot.

The empire has just built the ultimate weapon, the Death Star, a moon-sized battle station able to destroy entire planets with one shot of its death ray. The stolen plans for the weapon have been locked in R2-D2's memory by the princess before capture. Both robots

escape and land in a planet where they find Luke Skywalker, played by Mark Hamill, and Obi-wan Kenobi, played by Alec Guinness. The rest is pure movie fantasy.

Overall the film carries light psychological connotations within its comic book scenario.

The script, by no means weak, seems plucked right out of the pages of Flash Gordon and Buck Rogers.

The writing is good and the acting is not far behind.

Carrie Fisher proves to be a strong actress in this her second major screen appearance, the first in 'Shampoo,' and her portrayal of the strong willed princess puts an end to the stereotype of fairy tale princesses. Her acting is just a trifle short of brilliant.

'Star Wars' is definitely a movie for the fans of light hearted adventure and science fiction films.

The film carries a PG rating mainly because of the soft-core violent use of the futuristic weaponry.
